The purchaser is responsible for all legal costs for the transfer and the building is sold on as is basis. - BELL #12-55 DESAULNIERS & WIERSEMA & CARRIED that Council support the proposal by Bell Mobility to construct a communication tower for internet and cell services within our municipality. The location of the tower site is Part of River Range Lot 17 Township of Dilke PIN 56049 0195.
- OTHER The Acting Rd Supt was unable to attend the meeting, Council does wish to change operations in that a monthly written report will be requested from the Rd Supt, which outlines work both projected and completed with estimated costs for each project. Roadside cutting will start in the next couple of days. The monthly CBO report and the Fire Chief report were received and reviewed. Council reviewed the monthly report of the Clerk-Treasurer including updates on the locum doctor house, two doctors have signed an agreement for the next four years, the joint fire committee, a budget update report, OGDE & NHIC agreements have been approved, and reported the AMO meeting in Toronto re OMPF cuts. A public "visioning" meeting will be held Aug 15<sup>th</sup> for our OP & Zoning updates. We need a nominee for the Queen's Diamond Jubilee medal, due Aug 1<sup>st</sup> a couple of names have been suggested and each Councillor is to advise the Clerk-Treasurer by July 27<sup>th</sup> of their choice. A request was received from Riverside Health Care to meet with Council on doctor recruitment Council believes joint meeting with Rainy River would be best.
